The NAACP Presidency

The present local chapter of the NAACP as it exists today is not addressing itself to the fundamental needs and goals of the Black people of this community.

The Black Community needs a President who will not hustle for his own personal gains. While the next President should not be antiwhite, he must be pro-black. This means that he must possess an adequate understanding of the energy and the nature of the struggle before

His concepts for the organization must be based on the financial, physical, mental, and spiritual needs of Black people. To possess an adequate understanding of these concepts the President must live and work in the Black Community, and must be closely associated and identified with the problems of the community. He must have an honest, mutual love and respect for Black people--he must be motivated to work for the unity of the Black Community. He further must recognize individual differences and at the same time must be an instrument of unity in utilizing these differences.

The next President of the NAACP must be willing to walk and talk with the man in the street in an earnest endeavor to understand hip problems and his needs. This cannot be a phony relationship, the President must be willing to listen to the people. He must take the time and have the patience, so that when he speaks he must speak for the people.

PROJECTED PROGRAMS FOR THE COMING YEAR: (if elected)

The projection will be listed in their order of priority.

1. The membership of the NAACP must be increased to give the organization the necessary strength for meaningful and effective action.

2. The organization of the Youth Council is

a must! Here an attempt will be made to bridge the communication gap between youths and adults. Thus insuring that the NAACP will have young minds, new methods, and techniques of accomplishing organizational goals.

3. The committees of the NAACP must be activated to insure a division of labor and total organization participation.

4. (Economic Equality)

(A.) A proposed budget will encompass total financial aid for college students, students in trade schools, clerical students, ect.

(B.) We must negotiate from a position of strength (community strength) with unions for minority participation. When and if negotiations break down the organization will use this community's strength to deal effectively with the unions.

(C.) Dialogues will be established with Banks, Financiers, Convention Authority, Hotel association, etc., concerning the needs of the Black people and seek ways and means of eleviating these needs.

5. A Black Heritage library located in West Las Vegas is needed.

A permanent voter registration and voter education project office is imparative.

7. The organization will continue to lead the struggle for individual and group civil rights.

8. (Housing) While we recognize the need for more housing we will work to bring quality housing into the community. We will oppose contractors and developers who build inferior homes in the Black Community creating future slums.

9. We will attempt to meet with other ethnic groups who have similar problems and discuss problems solving methods.

If I am elected President of the NAACP will endeavor to serve to the best of my bility the needs and aspirations of the Black Community. The above suggestions are some of the plans that I believe merit the attention of the NAACP. However, I need your vote to begin. Your confidence in me is our beginning in this challenging endeavor.
