All CCSD High Schools Fully Accredited

All Clark County School District high schools are fully accredited by the Northwest Association of Secondary and Higher Schools, according to Theron Swainston, Assistant Superintendent and a member of the nine-man Board of Trustees of the Association.

Six schools--Western, Las Vegas, Rancho, Clark, Valley and Basic--were accredited with "fully approved" status this year, as opposed to accredited with "advised" status last year. "Fully approved" accreditation is the highest recognition granted by the Northwest Associ-

"Fully approved" accreditation is the highest recognition granted by the Northwest Association, which is one six regional agencies that grant accreditation to high schools and colleges in the United States. Approximately 2,000 high schools and higher educational institutions in Nevada, Utah, Idaho, Montana, Oregon, Washington and Alaska are members of the Association, which is a voluntary professional corporation responsible to no political organization.

The six large metropolitan high schools operated by the Clark County School District were placed on fully accredited, but "advised" status last year because classes were too large to meet Association guidelines. Swainston said this problem was largely eliminated this year by refusing to offer classes with very small enrollments, thus reducing class size in other courses.

One Dead - Two Go Free In Sunday Altercation

Eddie Atkinson, 51 of 1233 Monroe was shot to death in the early hours of Sunday morning.

According to reports Frank Allen, 45, gave Miss Willie Lee Carpenter a ride to the store upon their return, Atkinson had his car parked blocking the driveway.

Both Miss Carpenter and Allen asked him to move his car. Atkinson refused and an arguement followed. Atkinson was reported to have gotten out of his car with a pipe and preceeded to chase both Allen and Miss Carpenter, attacking them, with the pipe. Allen armed himself, when Atkinson attacked him again, Allen shot him.

There are rumors and reports that he was shot several times with different caliber guns. Miss Carpenter was arrested, but after the Police investigation, she was released. Because the autopsy showed that the bullet which killed Atkinson was fired from a different gun, than the one belonging to Miss Carpenter.

Authorities have ruled that there is not enough evidence to support a prosecution.
