Federal Judge Bruce Thompson's ruling on elementary school integration in the Clark County School District will be the subject of the program at a meeting of the C. V. T. Gilbert Prestige School Parent-Teacher Association Tuesday, January 19, at 7:30 p.m. Thompson ruled December 2 that no more than 50 percent of the enrollment in any grade in any school could be black after September. The school district has requested a clarification hearing on five points in the decision, and Thompson has scheduled that hearing for 4:30 p.m. Tuesday in Las Vegas.

Discussing the ruling will be attorney Robert Archie, president of the National Association for the Advancement of Colored People; Las Vegas State Board of Education members Cynthia Cunningham and Rosemary Clarke; Clark County School Board member and attorney David Canter; and attorney Frank Schreck, who represented

the League of Women Voters in the integration suit against the school district.

The meeting will be held in the Media Center at C. V. T. Gilbert school located at 2101 West Cartier Avenue in North Las Vegas. The public is invited.
