The Programs are: Project Pay (Preventive Addiction for Youth)--Drug Program Senior Citizen Emergency Food and Medical Program; and Information Research and Retrieval System--the latter, an Innovative Program.

the good of the Black Community. According to the 1970 census, the Black Community, because of its 24,760 population, could directly elect one senator and two assemblymen. If the legislature denies this opportunity to the Black Community it will be another ten years before reapportionment is again an issue. During that time the population will continue to increase and Black Voters will remain in a period of inadequate representation.

Again I charge you with the responsibility of voting in favor of the single district, thus making the Nevada Legislature truly representative of all the people.
