### **Voice Columist Nominated** To White House **Conference On Aging**

Mrs. Dorothy Johnson, whose "Food Forum" column appears weekly in the Las Vegas VOICE, has been twice accorded official recognition for her work with Nevada's Senior Citizen within the past two weeks.

In a letter from Governor Mike O'Callaghan dated July 1, Mrs. Johnson was notified that Because of your special interest and activities on behalf of our senior citizens, it is with special

pride that I am nominating you to represent our state at the White House Conference on Aging."

The Governor expressed his "sincere hope" that Mrs. Johnson will be able to accept the nomination, participate in the conference (to be held in Washington, D. C. Nov. 28-Dec. 2, 1971) and "Most important of all, in the months that follow, give us the benefit of your counsel and guidance as we search for solutions to the pro-

blems facing our senior citizens."

Subsequently, Rodger S. Trounday, Director,
State of Nevada Department of Health, Welfare, and Rehabilitation, named Mrs. Johnson as a member of the Advisory Council to the Division of Aging Services for the State of Nevada which became an official state agency on July 1, 1971.

Also noting Mrs. Johnson's demonstrated con-cern for 'our Senior Citizens,' Trounday's official notification stated that her appointment to the Council will extend from July 1, 1971 to July 1, 1973 and concluded "Your letter of acceptance to this position will be most welcome.'

The VOICE has learned that Mrs. Edythe Abington and Rev. J. L. Simmons, pastor of the St. James Baptist Church, were also among the Nevadans nominated by the Governor as offical state delegates to the White House Conference on Aging. Round trip transportation and four days per diem at \$25.00 is provided each delegate to the Conference.

#### **Juvenile Services Open House And Dedication** Ceremonies


Three prominent Las Vegans and three Southern Nevada associations were honored Saturday for their donations, totaling more than \$30,000
