"BLACK ENGLISH" A SLOPPY TERM SLANDERING ALL BI

Black people in recent months have been discrediting themselves by falling into one of the oldest and most dangerous of traps. They are accepting terminology suggesting that behavior of some blacks is typical of the whole group. The offending terminology is so-called "Black" English.

A class in "Black English" has been set up at Brooklyn College with a Ford Foundation grant, a Missouri University professor has claimed seriously that "Black English" is a sep-

arate language instead of a dialect, numerous language-oriented groups have studied the nature and meaning of "Black English" and the Western Electric Company has produced a new record "to help bridge the language barrier between black and white Americans."

The term, "Black English," really is intended to denote the language spoken by some less-educated black people living in rural and urban enclaves and segregated so effectively that their speech patterns have become a closed-culture lingo--a dialect derived from American English.

But in order to get this questionable expression into proper perspective, we must recall that the term 'Black,' when applied to people with African-like skin coloring and hair texture, is acceptable because it then indicates the IN-HERENT AND PERMANENT PHYSICAL CHARACTERISTICS that invariable identify all members of a biological group.

LANGUAGE NOT BIOLOGICAL

Neither English nor any other vocal expression however, is a biological characteristic. Accents change with hearing and environment. Many Africans blacker then black Americans speak English with a British accent. Black people in the Caribbean area speak English with Spanish or French accents. "Black" when coupled with "English" therefore, cannot reasonably denote that the use of so-called "Black English" language is a racially or biologically controlled characteristic of all blacks. characteristic of all blacks.

Instead, what is called "Black English" really is a cultivated or learned lingo characterizing SOME blacks and other non-blacks who associate

with them.

This simple distinction is significant, for the failure to distinguish between (a) racial features and (b) learned behavior provided the basis upon which yesterday's slaveholders and today's racists could argue that black people were in-

They argued that black people were ignorant and then produced ignorant blacks to prove their point. But they neglected to indicate that these black people were ignorant not because they were black but because they had not been allowed to gain knowledge enabling them to behave differently.

INHERITED VS. ACQUIRED

The racists deliberately confused the significance of INHERITED racial characteristics such as skin color and hair texture with the significance of ACQUIRED behavior character-istics such as education, life style, and speech. The generalities resulting from this confusion led to stereotyping and to the acceptance of Stephin Fetchit and Amos and Andy types as valid representatives of most black people.

Why did linguists and other observers neglect to make noise about "Italian-English," "Jewish-English," "German-English," or the faulty English of other ethnic groups being integrated into American society?" What about the country and western English or the English of poor whites? Should poor white folks English be called "White English"?

Perhaps a better term for so-called "Black English" would be "ghetto talk." The term, "Black English," is objectionable because (1) most black people over the world do not speak it, because (2) it does not repre-sent the highest level of potential language development on the part of those who speak it because (3) it reinforces the arguments of those who would confuse INHERITED racial ancestry with ACQUIRED and changeable behavioral characteristics.
