struction trades in a manner which would have avoided acrimonious divisions between the civil rights and the labor movement.

Not surprisingly, Nixon coupled the announcement of the wage-price freeze with the revelation that he will delay his welfare reform scheme. The President's welfare proposal, although it contained many shortcomings, did represent the one positive Nixon program that could have helped the economic underclass. The President's lack of commitment for helping the indigent, unskilled, and the undereducated has never been displayed more clearly in his selecting welfare reform as the first sacrifice to his economic program.

Nixon's approach to the whole question of economic reform is filled with cynicism. For thirty months he has rejected measures to create jobs, to build housing, to help schools. Among the measures he has proposed, he has given a higher priority to the appointment of Haynesworth and Carswell than to critically needed welfare reform.

Now he asks the country to support his program despite its many flaws and inequities. Those within our society--such as labor leaders--who give voice to their doubts, are labeled "out of step" or are said by the Administration to be working against the country's best interests. These are strange words indeed coming as they do from an administration which, by its own actions, has admitted that two-and-a-half years of economic policy have been a dismal failure.

elderly poor.

For, as are all federally funded programs under the sponsorship of the EOB, services of the agency's Senior Citizen Program will be directed to the low-income; in this case, the senior citizen in Clark County whose subsistence allowance makes his everyday life one of quiet desperation and, far too often, one of tragic isolation.

Statistics reveal that of the 36,000 persons over age 55 in Clark County (1970 census figures), 3500 of them over age 65 are in the low-income group as are an additional 3,000 between the ages of 55 and 64.

Because these low-income senior citizens do not have adequate funds to purchase foods necessary to a nutritive well-balanced diet and often are not aware that food commodity and other services are available (Clark County Food Program Director estimates that only 900 of 6500 eligible senior citizens participate in the Food Commodity Program), the EOB Program for Senior Citizens is designed to assure necessary services for the maintenance of health, with equal importance upon involving this segment of society in successful organization to deal with issues and problems in their own behalf.

As specified in its proposal, the EOB Senior Citizen Program will provide outreach, information, and/or transportation services for approximately 6500 low-income senior citizens, insuring their participation in available programs. An additional 150 whose health problems demonstrate a lack of such services will receive medical and dental examinations and treatment. Also, nutritive supplemental food will be provided to 300 participants whose health problems are related to malnourishment and who have no means of receiving those services. Further, educational programs will be conducted whereby senior citizens are kept informed on nutrition, general health, and other services necessary to physical and psychological well-being.

The Program will also provide opportunity for senior citizens to sharpen and utilize existing skills while working toward a self-sustaining small business corporation through the establishment of a Fix It/Thrift Shop.

Other features of the Program will be the organization of a Food Buying Cooperative and a feasibility determination for establishing a Pharmaceutical Cooperative.

Beginning September 1, VISTA Volunteers will be actively engaged in locating senior citizens throughout the County eligible for participation in the Program. They, and all staff, will also happily assist individuals to determine their eligibility. A telephone call to the Senior Citizen component, 648-3280, will result in a visit from a VISTA Volunteer, or provide answers to any questions on the Program.
