Acting Reno Police Chief Bev Waller made a special appearance at the Tuesday North East Reno Outreach meeting, announcing that the controversial official police report of riot conditions and police action in North East Reno in July has been "officially destroyed." The report, submitted to former Chief Elmer Briscoe, who resigned under fire following grand jury investigations of irregularities in the department under his regime, was compiled by Police Officer Al Neilson. Waller stated that Neilson has been transferred following distribution of the report in question, and that the "official" destruction of the report quells any status the report may have

Chief bone of contention about the report was the inclusion of a list of some twenty plus citizens of the Black Community called activists and in-structions to keep these individuals under surveillance. Reaction to the publication of such a list caused extreme rancor among those on the list and the community in general.
