

FREE CLINICS AVAILABLE

The Economic Opportunity Board of Clark County is sponsoring Free Clinics at 940-A West Owens, in the East Mall of the Golden West Shopping Center.

You are invited to utilize the following services:

FAMILY PLANNING - Tuesday and Thursday 5:30 P.M. to 7:30 P.M. Family Planning includes Pap Smears, Pregnancy Testing, Birth Control, Counseling, Diagnosis and Treatment of Venereal Disease.

IMMUNIZATION - Tuesday, Wednesday, and Thursday 2:30 P.M. to 4:30 P.M. The Immunization Clinic provides shots for diphtheria, smallpox, whooping cough, measles, Tetanus (lock-jar) and the polio drink. Given by the Public Health Nurse—your child should begin his shots at 2 months but they can be given to anyone under 21 years old.

FAMILY COUNSELING—Family Counseling provides professional counseling to those who are experiencing emotional stress.

There Is A Program For Heroin Addicts

Family Counseling Service, a United Fund Agency, 318 Maryland Parkway, Las Vegas, Nevada, does offer help for the heroin addict. It offers a program under a contract with the National Institute of Mental Health. Family Counseling Service serves as the coordinating agency and provides individuals and group therapy, vocational counseling and training, job placement assistance, family counseling, temporary financial assistance, and urine surveillance.

Narcotic addicts who wish help in their rehabilitation and have no present pending criminal charges are eligible for the NARA program. It also provides for commitment to the program of certain other addicts charged with and convicted of specified crimes, but this is at the initiation and discretion of the court.

In this program, the addict is voluntarily or civilly committed to a period of hospitalization in Phoenix, Arizona or Lexington, Kentucky for from 4 to 6 months before returning to Las Vegas in the Family Counseling Services' 3 year after-care rehabilitation program. He may then return to school, enter into a job training program, or he will be helped to enter into other training which will be of help to him.

This is a civil court commitment program and is completely confidential. No information developed under this program can be used against the addict in any criminal matter.
