Every Tuesday Air 2nd Community Affairs Series

The second program in the new TV 3 community affairs series, "Every Tuesday," (at 10:00 PM Tuesday, Jan. 25), will feature a NEWS INTERVIEW WITH THOMAS BEATTY. Chairman of THE NEVADA STATE EQUAL RIGHTS COMMISSION, which enforces housing and employment discrimination laws.

Beatty, a young attorney with the Clark County Public Defender's office, was appointed to the commission in January 1971, by Governor Mike O'Callaghan. Beatty will face a panel of four Las Vegas newsmen, representing the Associated Press, KORK TV, the Las Vegas Sun and the LAS VEGAS VOICE.

The program is the alternating identity in the "Every Tuesday" series, is titled "Newsmakers and is moderated by Grant Sawyer, former governor of Nevada and now a partner in a major Las Vegas law firm. He will appear every two weeks as host of the "Newsmakers" program, which shares the Tuesday night time spot with "Compass Point," a discussion show that ponders the direction life is taking in Nevada. A protest against the adoption of the emergency program was made motion of Commissioner Bob Broadbent.

Speakers against the motion were Mrs. Ruby Duncan, president of the Nevada Welfare Rights Organization; Mrs. Petty Smith, coordination of the Clark County Economic Opportunity Board Surplus Food Commodies and Rev. Herbert Osmond, chairman of the human resources committee of the Clark County Ministerial Association.

All 3 spokesman felt that the people even those 1000 who would not be cut off under the plan would rather get the same allowances now being paid-than to have the money doled out for 6 months.

Mrs. Petty Smith stated that the ten dollars they would get under the proposed new criteria was almost less than nothing. Rev. Osmand accused the Commissioners of being more concerned about the powers of the upper class taxpayers than they were about the poor. He also chided the body spending large portions of the funds available on administration.

Mrs. Ruby Duncan challenged the Commission of several provisions of the emergency program. One being Section 300.210 which provides aid

for non-residents. Section 600.200 states that "rent will only be

paid for public housing units. Mrs. Duncan asked, "Isn't it true that the Nevada Revised Statutes require that you provide

aid to the legally poor."

This question was not answered. Mrs. Duncan did state that as long as the Hotels had food that they would eat.

COSMO HEARING CLOSES

The Las Vegas City Commissioners hearing of a Show Cause on the liquor license of the Cosmopolitan Lounge ended Monday night.

We say ended, but the end might not ever come. If the Commissioners let Elbert Lyles keep his license, the police department will be unhappy, and if they revoke the license, those who feel the hearings were a farce will be displeased.

If the Commissioners use this seldom used regulation that 2 Commissioners have hinted at using, we will have proof that they have two standards, one for the Black businessmen and a different one for white businessmen.

From the testimony given by officers, most of the arrest made on one witness occured in some of the same downtown hotels. It goes without saying that many other people are arrested many many times in the same places of business with (see COSMO, page 7)
