#### NOTICE

Tom Mulroy, Registrar of Voters, has issued a statement concerning inquiries received about filing for office.

"Because of the continuing calls being received at our office," Mulroy said, "it seems advisable to clarify the position of the Election Department at this time.'

There are but a few offices, to be open for filing, that are not subject to possible action by the Federal Court. The court has under advisement the districting as enacted by the 1971 Legislature and any offices that may be affected by court action cannot be filed for until their decision is announced.

Mulroy concluded that a ruling might be re-ceived during the first week in April.

Judicial offices are not related to the reapportionment case and thus the first filing for the 1972 elections was accepted on Thursday. Filing for re-election as Las Vegas Township Justice of the Peace was incumbent, Robert L.
