TAXPAYER SERVICE

If you are irked by a constantly ringing tele-phone, consider the Internal Revenue Service. During the first month and a half of this year, the IRS officers in Las Vegas and Reno received almost 23,000 telephone calls from taxpayers

with questions about, naturally enough, taxes. The questions range from "Where can I get a tax form? My kid scribbled all over the one I got in the mail." to "My husband ran off and took all our savings. Can I deduct this as a bad

Warren Bates, IRS Director for Nevada, said, "The calls are running about 20 percent higher this year than they were at the same time last year. We're hoping this indicates that more people are doing their tax returns earlier. Besides making it easier on us, the sooner a taxpayer files a return the sooner he will get his refund."

In addition to the phone calls, more than 13, 000 people have come into the IRS offices with

questions about their tax returns.

Bates said the IRS would rather have people call. "Many times people come in with questions that could easily have been answered over the phone. It's really to the taxpayer's advantage to call first. Sometimes we get crowded and people have to wait and then if they do come in without (see TAXPAYER, page 12)

beaten to death in the restroom of Friendly Liquors, 1602 North "H".

The investigation continues.

NAACP LODGES PROTEST

The Las Vegas Branch of the N.A.A.C.P. has joined with various community organization to protest what it terms "Official Discrimination." The decision of our City Commissionerssuspending the liquor license of the Cosmopolitan Cocktail Lounge and the excessive fine leveled against Elbert Lyles its owner.

Based upon statements made by certain Commissioners, testimony by witnesses and the charges leading to the Show Cause Hearings, the NAACP believes that the Commissioners showed contemp, dis-respect bias against the entire

Black community.

While the NAACP has a record of supporting Law and Order it is and has been a crusader for equal justice. It is the position of the NAACP that the commissioners actions were an example of unequal application of Justice, that they have conspired with fore thought to deprive a Black man of his right to do business in a prejudices manner. Giving creditability to the belief that there are two different sets of rules and regulations-one for Blacks and one for whites.

In the name of Equal Justice the NAACP calls upon the Commissioners to right the wrong it has committed against Mr. Lyles. (1) Holding long expensive hearings based on flamsy and questionable information. (2) The statements and conduct of city officials during the hearings. (3). The final decision on the hearing.

To turn its attention to more serious violations rampant within the Black Community.
