Stan Cobb To Speak In The Las Vegas Area

Las Vegas Economic Loss Told By Expert At FPC Hearings

Testifying before the Federal Power Commission in Washington, D. C., Bernard Malamud, associate professor of economics at the University of Nevada, Las Vegas, stated that a proposed 25 percent curtailment of natural gas to Southern Nevada would result in an economic loss to the area of \$18,660,000.

In addition to this one-time loss, Malamud testified there would be a recurring annual loss to the Las Vegas economy of \$9,198,000 in the event gas supplied were cut 25 percent.

Malamud is testifying on behalf of Southwest Gas Corporation before the Federal Power Commission. The FPC is conducting hearings on the allocations of natural gas to utilities and large-volume industrial customers in Nevada, Arizona and New Mexico served by El Paso Natural Gas Company.

He also pointed out that the use of alternative fuels, such as coal or oil, may lead to air quality deterioration which could reduce tourism to Las Vegas.

"A one percent reduction in tourism because of air quality deterioration will cause between a \$6,115,000 to \$8,195,000 reduction in income to Las Vegas," Malamud stated.

"Clean air is a significant asset to Las Vegas as a resort area," he added. "In a recent survey by a UNLV student 96 percent of the people interviewed responded that they would cease to come to Las Vegas if its air pollution were as bad as the condition prevailing in their respective home towns."

Malamud said his findings indicate that even one or two noticeable air pollution incidents could have severe consequences on local economy and the prospect of a major gas curtailment subjects Las Vegas to an extremely high risk of lost tourism and income.

them."

He told subcommittee members that 58 Nevadans were successfully rehabilitated under state programs in 1971.

"The group involved had total annual earnings of \$447,460 and paid \$111,000 in taxes prior to rehabilitation," Bible said. "The same group is now expected to receive annual gross income in excess of \$2,110,000 and pay more than \$527,000 a year in taxes."

Under existing law, federal funds are allocated to the states on the per capita income with the minimum allotment set at \$1 million.

Bible called the present minimum "a major inequity" for Nevada because the state's small population and great geographic area create "unique problems in the delivery of rehabilitation services to the handicapped."

"Inflation has greatly increased the cost of reaching the disabled," Bible said. "Nevada has substantially increased its support for rehabilitation services, but additional federal funds are needed to maintain the present level of services and to expand the program."

The Nevada senator also testified in favor of other provisions of the House bill, including:

--a new program to assist the severly hand-

icapped.

--Authority to appropriate \$25 million a year for grants to assist in maintaining the work capacity of individuals with end-stage kidney dis-

--authority to establish special centers for spinal cord injured individuals.
