Dear Mr. Anderson:

On March 31, 1972, I was terminated from Channel 3 - KORK-TV. I was a reporter for that station's news department for over two years. After trying to serve to the best of my ability, my employer and the community, you can imagine the shock I experienced when the News Director, Fred Lewis, told me I was terminated. Frankly speaking Mr. Anderson, I do not believe my firing was free of racial bigotry.

Perhaps you will recall our conversation some weeks prior to my dismissal - the first two weeks in February. I told you then of my belief the KORK's news department was not treating me with the same degree of fairness as it treated its white reporters. I might add that this same opinion was discussed with the NAACP's Executive Director, Jess Scott. Some of my reasons as I stated them before were: (1) lack of visual exposure given me as compared with the white reporters; and (2) lack of important stories assigned to me. There are many other subtle differences that I experienced while working with the news staff which are too numerous to list here.

You may recall that I expressed hope that things could be worked out. In retrospect, I don't know why I was so optimistic, considering the News Director didn't see fit to discuss with me in private any complaints he may have had a bout me and/or my job

a bout me and/or my job.

What I desire of your organization, is an impartial investigation into the working conditions of KORK-TV and its Black employees. Let us at least try and protect the few Blacks that are in the media against unfair and discriminatory practices.

Very briefly, let me give you a few of the reasons given me by Fred Lewis as to why I was being dismissed from the news staff:

1. The News Director stated that "I am tired of the flack I am getting from the

Black community."

2. He said there were complaints about my not being on the air enough and others questioning my fitness to be exposed at

As I stated before, I would like for the NAACP to take a look behind the scenes at our various news media and ask where are our Blacks, where can they expect to go in the company, and are they treated in a fair and impartial manner by superiors?

I do hope a copy of the following letter to the National Association for the Advancement of Colored People, will allay any further questions.

I do want to thank publicly, all those persons who have expressed their deep regret over my termination, but what I hope for most out of all this, is action to insure that there is minority representation at every radio and tv station in Clark County. We do have the right to such representation, and one letter to the Federal Communication Commission, in Washington, D. C. will bare me out.

Thanks Mr. Smith, for a chance to communicate with your many Las Vegas Voice readers.
