Joseph Prudhomme II, an employee of Lawyers Title of Las Vegas, has filed for Assembly District #18. PUBLIC NOTICE

A veteran who received an "other than honorable" discharge from military service because of drug use or possession may apply for a discharge review, the Veterans Administration reminded today.

Some months ago, Secretary of Defense Melvin Laird announced that military departments would "review for recharacterization administrative discharges issued under 'other than honorable conditions' solely on the basis of personal use of drugs or possession of drugs for such use."

It was explained the purpose of the review policy is to provide an opportunity for this group of veterans to become eligible for VA medical treatment. VA has 44 drug treatment centers, but is barred by law from treating veterans with dishonorable discharges.

Following the Secretary's announcement, Administrator of Veterans Affairs Donald E. Johnson issued a directive to VA personnel to be on the alert for veterans with such discharges, and to encourage them to request reviews.

Johnson pointed out that each review application must be submitted to the military department that issued the discharge, and that self-explanatory review applications (DD Form 293) are available at VA offices and military installations.

POLICE CAREER

Young men interested in training and experience leading to a career in police work now have a new opportunity provided by the U. S. Army. Specialist Four Douglas G. Carnahan, representing the 508th Military Police Battalion of Fort Riley, Kansas, is presently on duty with the Army Recruiting Station in Las Vegas, 557 East Sahara (telephone 385-6284). SP4 Carnahan is seeking to interest local men in the MP's; the Army will guarantee qualified men electing a 36-month enlistment that on successful completion of basic training and military police training, they will be assigned for 16 months to the 508th MP Battalion at Fort Riley. SP4 Carnahan is seeking men over the age of 18 years, and over 5'9" in height. Applicants must be intelligent and physically fit. High school graduates are preferred. A civilian driver's license is required, along with a clear police record.

SP4 Carnahan served as a military policeman at Fort Riley before being assigned to recruiting duty. He is available at the Las Vegas Army Recruiting Station from 8 a.m. to 5 p.m. weekdays to answer questions about Fort Riley and the military police. He indicates that training and experience as an MP is a good way to prepare for civilian police work; in addition, an MP is entitled to all the benefits, in terms of pay, medical care, and education, due any serviceman, and is entitled to complete veteran's benefits on honorable discharge from the Army.
