SEX AND THE BLACK MALE

Are black men sexually superior to white men? Dr. Alvin F. Pouissant, a black Harvard psychiatrist, examines some hard facts and fantasies about the legendary "black stud" in the August "Special Issue" of Ebony. Says Pouissant:

"Black male sexuality has been enveloped in myths, fantasies, distortions and streotypes. Popular literature alludes to black prowess, but sexual studies and reports provide few hard facts. Black for uncertain reasons have not been analyzed in the major sex studies and the common beliefs about black male sexual power cannot be confirmed or rejected on the basis of objective information."

Black men have been both glorified and victimized because of their alleged sexual prowess. Many black men have been publicly castrated

Voter Registration

Registrar of Voters Stanton B. Colton has issued the following statement: "Registration for the Primary election of September 5th, 1972, will close on Saturday, August 5th at 9 P.M. The Election Department offices, at 400 Las Vegas Boulevard South, will be open evenings from 7 P.M. to 9 P.M. Tuesday, August 1st. through Friday, August 4th, and on Saturday, August 5th, from 9 A.M. to 5 P.M. and from 7 P.M to 9 P.M."

Colton also wishes to remind all field deputy registrars that their Affidavits of Registration, completed and blank, are to be turned in at our offices by 9 P. M. on August 5th, or sooner if possible.

EOB Public Meeting Set

A special public meeting called by the Planning Committee of the Economic Opportunity Board to set Agency priorities for the next three years will be held Tuesday, August 8 at 8:00 P. M. in the EOB Community Hall at Economic Opportunity Center, 900 West Ownes Avenue. Primary purpose of the meeting is to afford community residents opportunity to express their views on community needs. Based on these expressed views, the EOB will establish priorities in the following areas of service: Health, Economic Development, Education, Food, Housing, Legal, Community Organization, Jobs, Child Care/Head Start.

The August 8 public meeting is the initial segment of the Community Action Agency's planning process pre-requisite to submitting funding requests to federal agencies. Groups or agencies wishing to operate EOB programs or a determination on availability of funds within the "anti-poverty designation should submit proposals prior to August 31, 1072.

It is common knowledge that it does cost money to put on a campaign. Why so many people file and then proceed to seek money and support, is putting the cart before the horse.

Prudent persons would attempt to gain support or pledges of support - before they file! We wonder.

The instigators of last weeks mass meeting were too busy with their campaigns to attend this weeks meeting. Could it have been - a rule or ruin policy that kept them away? As important as the subject matter is we need to proceed with haste to band together in an attempt to correct this evil that hovers over our community - yea over the entire valley.
