Dr. Charles Richard Drew

WASHINGTON, D.C. - The late Dr. Charles Richard Drew, eminent surgeon credited with perfecting the extraction and storing of blood plasma for the American Red Cross Blood Bank supplying it to U.S. forces during World War II, will be highlighted at the opening Public Program of the Shriners 79th Annual Convention Sunday, August 20, at 2 p.m.

This initial and traditional observation by the Prince Hall Shriners will be held in the Washington Hilton Hotel, headquarters of the sessions.

Dr. Drew was a native Washingtonian and during his distinguished career at one time headed the Surgical Department of Howard University Medical School and Chief Surgeon and Chief of Staff of Freedmen's Hospital, both in Washington.

Charles Richard Drew was the son of Richard Thomas and Nora (Burrell) Drew and was born June 3, 1904. He died in an automobile accident in North Carolina, April 1, 1950 when a hospital refused to treat him and give him some of the blood plasma he helped perfect and which might have saved his live.

Dr. Drew earned the A.B. degree at Amherst College; his M.D. degree at McGill University Montreal, Canada; D. Sc. degree in Medicine at Columbia University and had numerous honor-(See Drew page 3)

Abernathy Says Evict Nixon

DALLAS, TEXAS (August 17, 1972)— The number one priority for black and progressive people in 1972 is "to evict Richard Milhouse Nixon from the White House," Dr. Ralph Abernathy said in a major address to the 15th Annual Convention of the Southern Christian Leadership Conference being held here.

The SCLC President pledged the organization's total staff and Chapter resources across the South and in 24 major cities to work for the election of local, state and national candidates who respond to the needs of poor people. He said that SCLC's political organizing will include intensive voter registration, political education, and massive get out the vote drives on election day in November. He noted that this will include organizing on black college and high school campuses — "where we want to help students transform Black Power from a slogan to a reality. We will also work in the ghettoes of the nation and we will be in coalition with other forces such as the young, poor people's organizations, the peace movement, and the harassed and victimized working men and women of America."

Many Black Children Unprotected Against Polio, Pediatrician Reports

WASHINGTON, D.C. -- The number of black children who are not protected against polio would not be so alarmingly high if their parents could remember the days when this crippling disease was a constant menace, says Dr. Roland B. Scott, professor and chairman of the department of pediatrics at Howard University Medical School.

Dr. Scott was responding to government statistics which show that half the children in many inner-city areas are not fully immunized against polio. In all, says the Center for Disease Control, a third of all children in the one-to-four-year age group have not received the full series of polio vaccine doses.

Dr. Scott and pediatrician members of the National Medical Association are urging parents to make sure that their children are fully protected against polio. The Association, with head-quarters in Washington, D.C., is the nation's largest organization of black physicians.
