"The Black Press is to journalism what jazz is to music, in that they both bare the souls of Black folk."

Without a Black-owned media, Black news would be treated like the Black blues -- the white man controls the Black communication faucet and he will decide when it should be turned off and on.

It appears to me that one method of over-coming this deficiency would be to make the reading of the Black newspaper a part of every elementary and high school civic curriculum. It is only with this type of indoctrination that the relevance of the Black Press can ever surface.

The Black Press has an obligation to print the truth about controversial issues, be they political or otherwise.

The election results just in shows that West Las Vegas voters had its problems trying to figure out which friend they should vote for. Since none of the candidates had previous experience in the offices they were seeking, made the choice even more difficult.

Whether voters made the wise choice or not will depend upon the voting records of the winners in November. At least we know that voters have a strange way of making their decisions.

Non-Whites Now Receive 10% of Social Security

A study shows that 10 percent of the people now getting monthly social security checks are non-white - compared to 7 percent in 1959, according to social security officials here.


"Over 27 million people get monthly social security payments now," a social security spokesman said, "adn about 2.7 million of them are non-white. Thirteen years ago, according to the study, 13.7 million people got social security checks 967,000 of them were non-white."

Social security now pays over \$3 billion a month to retired and disabled workers and their families, and the families od deceases workers who were insured under social security. In 1959, the figure was about \$845 million a month, according to the spokesman.

The average monthly social security payment is now \$116 to non-white retired workers and \$132 to whites, the study indicates. In 1959, the average was \$61 to nonwhites and \$76 to whites. The amount of monthly social security payment is based on the worker's average earnings over a period of years.

The study was conducted by the Social Security Administration.

About 11 percent of the U. S. population is non-white.



Wrong Claim Number Can Delay Medicare Payment

People covered by Medicare can assure faster payment of their medical insurance claims if they make sure their correct claim number is on the form, according to Ed Cocks, social security dostrict manager in Las Vegas.

Use of the wrong number, or omission of the number entirely, is responsible for one of every three delays in the payment of medical insurance claims, he said.

"Your health insurance claim number identifies your claim when you request Medicare payment on bills for medical services," Cocks said. "If you put a wrong number--or don't enter a number--on a 'Request for Medicare Payment' form, a search for your correct number is necessary. The search can delay your payment."

The health insurance claim number appears on the card issued to everyone covered by Medicare, Cocks noted. It has nine digits and a symbol, such as A, B, F2. "It should be copied—including the symbols—onto the designated blank on the 'Request for Medicare Payment' form." he said.

The medical insurance part of Medicare helps pay for doctor bills and many other medical expenses for almost everyone 65 and over. "Request for Payment" forms should be sent to Medicare, Aetna Life Insurance Company, Box 3077, Reno, Nevada 89501, the health insurance organization that handles Medicare payments in this area.

The forms are available at most doctor's offices and at any social security office.

If a doctor and his patient agree, the doctor can be paid directly by Medicare. If the patient submits the claim, the Medicare payment goes to him, Cocks said.

Medicare pays 80 percent of reasonable charges for covered medical services after the \$50 annual deductible has been met. The medical insurance is the voluntary part of Medicare, funded by individual premiums that are matched by the Federal Government. It supplements Medicare hospital insurance, which os funded by regular social security contributions and helps pay hospital bills of people 65 and over.
