MIKE O CALLAGHAN, GOVERNOR OF THE STATE OF NEVADA, EXECUTIVE CHAMBERS CARSON, CITY, NEV. DEAR GOVERNOR, WE THE BLACK HAIR DRESSERS OF LAS VEGAS, TAKE STRONG EXCEPTION TO THE REMOVAL OF MRS MARY ADERHALT FROM THE COSMETOLOGY BOARD. WE FEEL THAT THIS IS AN ACT OF RACIAL DISCRIMINATION IN THAT MRS ADERHALT IS BLACK AND WAS THE ONLY ONE ON THE BOARD WITH OUTSTANDING QUALIFICATIONS, WHO IS ALSO EXPERIENCED IN THAT WORK, WHICH IS A NECESSITY IN THIS COMMUNITY. WE FURTHER NOTE THAT FOR YEARS THE LAS VEGAS BEAUTY COLLEGE WAS THE. ONLY SCHOOL IN WHICH BLACKS COULD GET TRAINING IN COSMETOLOGY BECAUSE OF RACIALLY EXCLUSIONARY PRACTICES IN OTHER SCHOOLS. FINALLY, WE WISH TO STATE THAT WE FEEL N.R.S 644040(2) IS UNCONSTITUTIONAL BECAUSE IT SYSTEMATICALLY EXCLUDES OVER NINETY EIGHT PERCENT OF THE BLACKS FROM SERVING ON THE COSMETOLOGY BOARD. IF MRS ADERHALT'S APPOINTMENT WAS ILLEGAL THEN JUSTICE AND FAIR PLAY DEMANDS THAT IT SHOULD HAVE BEEN CORRECTED, AND FAVOR THOSE WHO COULD ONLY ATTEND THE ABOVE SCHOOL FOR THEIR TRAINING
