



PROFILE



WILLIAM H. (BOB) BAILEY

William H. (Bob) Bailey was born in Detroit, Michigan, February 14, 1927, one of four children, offsprings of the late John H. and Margaret Bailey.

Bob began his education in Cleveland, Ohio where he attended Bolton & Case Woodland Elementary School, Kennard Jr. High and graduated from Central High School as president of his class. He received his Bachelor of Arts Degree form Morehouse College in 1946.

Bob started to work at the early age of eight as a grocery delivery boy and was later promoted to clerk and butcher's assistant. While attending school he held many different jobs, hospital attendant, painter, process server to name a few and while in college he worked as a waiter at the Atlanta Country Club.

In 1946, Bob began his career in show business. He has been a featured vocalist with the Count Basie Orchestra, had the juvenile lead in the musical comedy "Sugar Hill", won first prize on the Arthur Godfrey talent show, appeared on Ed Sullivan's Toast of the Town show twice, toured the top supper clubs as as a featured artist, and came to Las Vegas in 1955 as master of ceremonies, singer and assistant producer for Les Brown at the Moulin Rouge Hotel.

Bob has been married to Ann (neePorter) for twenty years and is the father of two children 11-year old John and Kimberly who is nine.

In 1961 Bob attended Nevada Southern University and received his Real Estate Brokers License. He was the first Chairman of the Equal Rights Commission, a position he held for six years, Regional Director of the first Western Regional Conference of State Civil Rights Commission, Coordinator of the first On the Job Training Program with the opening of the Circus Circus, a position which provided training for Mexican-Americans, Indians and Blacks in job categories heretofore unavailable to them. He established the first "free" training program for dealers at the Stardust Hotel, was organizer of the first training program for Keno Dealers in the State of Nevada.

Bob is a member of the Las Vegas NAACP, Kiwanas, a 33rd Degree Mason, Alpha Phi Alpha Fraternity, Las Vegas Chamber of Commerce, Christian Fellowship of Vegas, Board of Realtors, Board of Realtors, Board of Realtist, Las Vegas Press Club, National Association of Business Development Specialist, Screen Actor Guild and the Musicians Union Local 369.

Bob's list of credits are so numerous this entire profile could be devoted to this portion of his life. The most recent, after receiving his basic degree and Post Graduate Degree in Minority Business from Howard University Business Law School he was appointed to write and direct the first Business Development Company in the State of Nevada (NEDCO) which he recently opened at 618 East Carson.

The purpose of NEDCO is to assist Minority Businessmen in obtaining SBA and Bank loans to start new businesses and also assist businessmen in their first year of business with their marketing, bookkeeping and management assistance.
