H. P. "FITZ" FITZGERALD

Huedillard Paris Fitzgerald, one of ten children, was born to Thomas and Millie Fitzgerald October 15, 1917, in Danville, Virginia.

Fitz received all his education from elementary school through college in the State of Virginia, where he was valedictorian of his high school graduating class. In 1941 he graduated from Virginia State College in Petersburg, Virginia with a Bachelor of Science Degree in Art Education, and received his Masters degree in School Administration and Supervision from the University of Nevada, Reno, becoming the first Black to receive a Masters degree in the history of the university.

Fitz served five years in the military service during World War II, and saw action in the Pacific Theatre Operation with the famed 93rd "Blue Helmet" Division, earning the Bronze Star and numerous other citations. He was honorably discharged in 1946 with the rank of First Sergeant.

He moved to Las Vegas in 1946, and worked as a laborer, carpenter, painter and draftsman before being employed by the Clark County School District in 1947, as a teacher. While with the School District, he served as Art and Vocational Instructor, Special Program Evaluator, Vocational and Technical Advisor, and became the first Black principal in the State of Nevada, (four years before integration came to Las Vegas), when he was appointed to this position by the then School Superintendent, Dr. R. Guild Gray, in 1956.

When the Southern Nevada Manpower Training Center (Skill Center) opened in 1970, Fitz became a member of the Clark County Community Staff as Assistant Director. He was appointed Area Manager of the local office of the Nevada State Employment Security Department, comprising all of Clark, Lincoln and Southern Nye Counties in 1971 by Department Chief, Robert Archie, a position he presently holds.

Fitz has been a licensed General Building Contractor and Real Estate businessman for more than two decades in Las Vegas.

He is presently actively involved in more than two dozen committees, organizations boards and commissions. While in Nevada, he has been a participating member of the Boy Scouts of America, Camp Fire Girls Board Member, YMCA Counselor, PTA Life Member, National Association of Elementary Principals, NAACP, National Education Association, Governor's Mental Health and Mental Retardation Board, City of Las Vegas Electrical Examiners Board, White House Conference on Children and Youth, EOB Board, Variety Foundation Committee, Clark County Association for Retarded People Advisory Board, Army Reserve Corp., Las Vegas City Recreation Board, Clark County Democratic Central Committee, and Omega Psi Phi Fraternity, to name a few.

Fitz and his Virgie (nee Holliman) have one son, Ronal Paris, who is entering the construction business as an apprentice carpenter.
