Q--What should I do if my VA benefit check does not arrive on time? A--Two things. (a) Wait long enough to be sure the mails have cleared. (b) Write to the VA regional office which has your claim file, including your name if you're a veteran, or the deceased veteran's name if it is a death claim, and your claim number. Never write the Treasury Department, as this will only prolong the delay in receiving your check.
