## Meany Blast HEW's Welfare Proposals

AFL-CIO President George Meany made a public demand that HEW withdraw its proposed changes in welfare regulations on the grounds that those proposed changes would be a blatant invasion of the privacy and democratic rights of the most defenseless and deprived people in America.

CARSON CITY--Director Robert Archie of the Nevada Employment Security Department today May 22, 1973 annouced his resignation effective July 2 to return to private law practice.

Archie, 32, was named to direct the state agency by Gov. Mike O'Callaghan in March, 1971.

Gov. O'Callaghan said he had accepted Archie's resignation "with deep regret at losing one of Nevada's outstanding public servants." The governor added Archie "has performed his duties with consummate ability, making the Nevada Employment Security Department the top job-finder in its region and one of the Country's finest such agencies."

Archie, the state's highest appointed black official and the nation's youngest chief of an employment security department, said his return to private law practice is "one of mixed feelings"

He said, "my service for Governor O'Callaghan and the state of Nevada has been the most rewarding of my life." He credited the success of his tenure to the governor, "whose heartwarming confidence in me was always accompanied by no-nonsense instructions to get the job done."

But Archie added, "I am in my prime earning years and my family and personal commitments require that I devote myself to their financial well-being. I can do that most effectively as an atomory."

Archie said, however, that he "fully intends to return to public life at a later date."

Archie will become a law partner with Las Vegas attorney George Spizzirri (and specialize in criminal law. In addition, Archie said he will also be fulltime instructor for the Clark County Community College, administering a two-year degree program in police science.

In the two years the Nevada Employment Security Department has been under Archie's direction, the agency jumped to top place in its region for helping the public find jobs. The Nevada department now outranks its counterparts in California, Arizona, Hawaii and Guam. The Nevada agency also leads the region in finding jobs for veterans and ranks second for placing jobseekers in work lasting more than three days. The U. S. Labor Department has recognized Archie's achievements with membership on high-ranking federal committees, notably the executive committee and the legislative committee of the Interstate Conference of Employment Security Agencies.

Encouraging more use by the public of the department's services, Archie in the past two years has averaged about four speeches a month throughout Nevada and his newsmaking activities have been widely recorded in the press.

Under his direction, the department's services are regularly mentioned in public service an-
