Archie will make his residence in Las Vegas with his wife Inez and their two-year-old son, Jason.







SENATE BILL 31, INTRODUCED BY STATE SENATORS MAHLON BROWN, JAMES GIB-SON, JOHN FOLEY, MEL CLOSE, CARL DODGE, ARCHIE POZZI and COE SWOBE, HAS BEEN ENACTED INTO LAW.

SO THAT OUR ELIGIBLE SENIOR CITIZENS IN CLARK COUNTY MAY HAVE EVERY OP-PORTUNITY TO OBTAIN THE BENEFITS OF THIS NEW LAW, LISTED BELOW ARE SOME OF THE PRIME PROVISIONS OF IT:

- In order to file, claimant must be 65 years old on or before the first Monday in September of the year in which he or she files.
- 2. In order to be eligible, the senior citizen and/or spouse together must make not more than \$5,000 gross income per year. Gross income will be defined by the State Tax Commission on the application form, but generally will include such income as earnings, interest, pensions, retirement benefits, social security benefits, except Medicare, old age assistance, welfare payments, capital gains, bequests, gifts, disability payments, unemployment benefits, etc., etc.
- Proper forms will be provided in the near future by the Nevada Tax Commission. These
 forms will probably be available in the various County Assessor's offices throughout the
 state. The claimant after completing the form will mail it directly to the Nevada Tax Commission at Carson City, Nevada.
- Application deadline is the first Monday in September. By law, the Tax Commission must make the refund by the first Monday in November of the same year.
- 5. This property tax relief is effective this year on property taxes due July 1, 1973.
- 6. If your property tax on the dwelling in which you live exceeds 7% of your gross income, the difference between the two figures is your refund. If your property tax does not exceed 7% of your gross income you receive no refund. The maximum refund possible is \$300 per year.
- The relief DOES cover senior citizens who are renters (renters in federally-subsidized apartment houses are excluded). Up to 15% of rent paid is considered accrued property tax, insofar as renters are concerned.
- Mobile home owners are eligible and will be treated essentially the same as a residence dwelling.
- Quarterly payments of tax will be allowed. The Tax Commission hasn't decided yet how they plan to work the refund mechanism.
- 10. The term "65 years of age" refers to the head of the household who is responsible for paying the property tax. In most cases a man and wife by virtue of their joint ownership of their house or trailer can both be construed as being the head of the household and either could file the claim. The Tax Commission will clarify this situation by regulation.
- A claimant may receive assistance under this law even though such claimant also receives a property tax exemption as a widow, blind person or veteran.
