DUI INJURY PENALTY INCREASED

CARSON CITY---Effective July 1, 1973, a person convicted of driving under the influence of intoxicating liquor, controlled substances or other chemicals who causes death or substantial bodily harm to another person is guilty of a felony pursuant to a new section added to Chapter 484 of the Nevada Revised Statutes.
This provision was one of the bills passed by the 1973 Legislature directed toward combating highway deaths caused by the drinking driver.

Colonel James L. Lambert, Chief of the Highway Patrol Division of the Nevada Department of Motor Vehicles warns of the seriousness of the penalty involved in committing this violation as conviction of a felony carries a penalty of imprisonment in the State prison for not less than one year nor more than six years, or by a fine of not more than \$5,000 or by both fine and imprisonment.

A person is considered driving under the influence of intoxicating liquor when he has reached 0.10% or more of alcohol in his blood stream. Driving under the influence is also applicable to people who drive under the influence of controlled substances rendering them incapable of safely operating a motor vehicle.

NEW RESIDENCY LAWS FOR DRIVERS

CARSON CITY---Effective July 1, 1973 a new resident of Nevada will be required to obtain Nevada vehicle registration and license plates for his vehicle and apply for a Nevada driver's license within 45 days of moving into Nevada. If a vehicle is used in this state by a new resident for a gainful purpose the owner will immediately have to apply for Nevada registration and a Nevada driver's license.

Howard Hill, Director of the Nevada Department of Motor Vehicles, says that the new law allows the Department to prorate Nevada Registration fees and Privilege tax and credit will be allowed in the amount of one-twelfth for each month remaining on the registration period in the state of former residence. New residents will be placed on Nevada's 12 month staggered registration system and there will be no loss of revenue to the State through the new proration procedure for new residents.

The new resident's law does not include persons who are actual tourists, out-of-state students, border state employees, seasonal residents or occupational transient workers.

ERNI MARSHALL DENIES CHARGES

Erni Marshall in a statement to the Voice said that when he was arrested for possession of a controlled substance, he advised the arresting officers that he had a prescription for the medication, seconal (sleeping pills). Following his release on a hundred dollar bail for a traffic citation, he went to the detective division of the NLV police department and presented the prescribed medicine bottle to a detective, and was advised that the substance taken from him at the time of his arrest was in the process of being analyzed.

Marshall said that several local papers - have carried news items which stated that he had been booked for possession of narcotics. Erni fell
