game of arrest, arraignment, bail and back on the street again currently prevalent.

Therefore, this office submits the following steps and conditions in recommendation to the County Commission for a course of immediate action. The power we need to enact strict penalty laws for soliciting and resorting and prostitution crimes is contained in NRS 244.357. We need this. The enactment we seek will enable us to enforce the following steps:

STEP 1: First offense, a \$250 fine.

STEP 2: Second offense, a minimum of 30 days in jail.

STEP 3: Third offense and beyond, 30 days to six months in jail.

In accordance with these necessary and forceful steps, there should be formed a special vice squad in the Metropolitan Police. We will cooperate with the newly formed Police Commission to secure funds from any available source to get the manpower needed to staff the vice squad.

Effective arrest patterns should be set up. Trial date should be immediate in Justice Court and cooperation from District Court regarding appeals so as to expedite the cases quickly and not have the prostitutes and pimps go through the old revolving door at the County Courthouse.

I stand ready with all of my staff to implement this plan or any other, or combination of plans in order to stop this rapidly growing cancer of prostitution on our Las Vegas environment.

Mr. Elder said he was willing to meet with Mr. Coleman because he felt their differences could be ironed out, but evidently Mr. Coleman had other ideas. Mr. Elder has filed a complaint with the Las Vegas Police Department.

When POOR PEOPLE PULLING TOGETHER brought this incident to the attention of Mr. Arthur Sartini, Executive Director of the Las Vegas Housing Authority, his comment was that Mr. Coleman had probably been provoked into fighting. Mr. Coleman, when contacted by PPPT said "I thought he might hit me, so I hit him first."

Albert Coleman has not been suspended or admonished. He continues his job as manager of Marble Manor. What do you suppose would happen to any one of us if we attacked some one because we thought he MIGHT do us harm?
