#### Bible - Cannon **Vote Against FPC Appointment**

WASHINGTON--Nevada Senators Alan Bible and Howard Cannon praised the Senate's decision to hold-up the nomination of Robert Morris to be a member of the Federal Power Commission as 'a major victory for the American consumer.'

Bible and Cannon were among 49 senators voting today to recommit the Morris nomination to the Commerce Committee, a step which in all likelihood will kill the nomination. Final vote on the motion was 49 to 44.

"The Federal Power Commission occupies a key position in our Nation during the current energy crisis, "the Nevada Senators said in a joint statement. "It is charged with regulating the natural gas and electric industries in order to insure that prices charged for these essential commodities are fair to the consumer.

"Unfortunately, in recent years the Commission's membership has taken on a strong proindustry orientation which has led to decisions costing the American consumer millions of extra dollars.

Bible and Cannon said they were not questioning Morris' integrity but noted he has represented one of the nation's largest oil companies for many years.

The question is not whether the industry's view deserves representation on the FPC, they said. "It is whether any other view is to be represented.

"Mr. Morris' integrity and competence are not in question," Bible and Cannon added. "But at a time when public confidence in the federal government is not high, it would be a mistake to award still another seat on this important agency to a lawyer who spent most of his career speaking for the oil and gas industry."


The Nevada Senators pointed to the Commis-

sion's recent approval of a 73-percent increase in well-head rates for natural gas which they described as "unconscionable."

"The addition of another pro-industry spokesman will hardly improve this situation," they said. "What is needed on the Commission is a new member to speak on behalf of the millions of American consumers who annually pay more than \$30 billion for natural gas and electricity."

The Morris nomination was strongly opposed by the three million member Consumer Federation of America.
