VA FACTS

Q--Someone told me that I can apply for a home guarantee loan under the GI Bill even though I served during World War II. Is this true?

A--Expiration dates on GI loan eligibility of World War II and Korean veterans was restored where their entitlement had expired. Eligibility for GI loans now runs until you have used it. You may obtain the necessary information and forms from your nearest VA office.

Q--An extra large dividend put me over the income limit this year. Will this cause my VA pension to be discontinued?

A--No. As long as this income could not have been anticipated and was of a non-recurring nature, it will have no effect on your pension.
