

Hunting & Fishing Day Proclamation Signed

Governor Mike O'Callaghan has signed a proclamation declaring September 22, 1973 as Hunting and Fishing Day in Nevada in recognition of the contributions of Nevada's hunters and fishermen to conservation and recreation.

Nevada Hunting and Fishing Day will coincide with the same National observance signed into being by President Nixon after unanimous passage by Congress recently.

In the proclamation, Governor O'Callaghan cites that hunters and fishermen in Nevada and throughout the U.S. are responsible for the foundation of state wildlife agencies and the resulting laws, regulations, licenses and bag limits which have conserved the nation's game and nongame fish and animals through the years.

He also pointed out that hunters and fishermen asked that their recreational equipment such as guns and fishing poles be taxed and the money be used for land acquisition, research and habitat management for fish and wildlife.

The President's and Governor's signatures have cleared the way for sportsmen's clubs local and nationwide to hold NHF Day programs on September 22 to explain to the public how all hunters and fishermen have contributed to conservation in the U.S.


