

#### **CHURCH OF SCIENTOLOGY**

The Church of Scientology Committee on Public Health and Safety today released a nine page report on their review of drug therapy for Clark County school children. The report includes recommendations for local upgrading of the program and calls for action by the Food and Drug Administration to clarify the use of stimulant drugs for hyperactive behavior.

The Committee's initial report dealing with the Medical Consultant Program was released last fall. In mid-March, Governor Mike O' Callaghan called for a review of the program which the Committee offered to undertake.

According to Committee spokeswoman Rev. Laurie Zurn, both negative and positive aspects of the program were explored. Parents, teachers, school nurses, psychologist, and private physicians were consulted.

physicians were consulted.

"Locally, the lack of physicals for children prior to placement on the program seems most serious." she said. "However, an underlying problem is the definition of hyperkinetic behavior which is open to wide interpretation. While extreme restlessness and frustration on the student's part are considered symptoms, so are withdrawn and very quiet behavior," Rev. Zurn added.

The report charges that the FDA must clarify "hyperkinetic" and additionally must monitor the long term effects of the stimulant drugs used on such programs.

Copies of the review have been submitted to the FDA as well as to Nevada Health Planning officials.
