NEW YORK - Who was the first American Black Roman Catholic Bishop? Who served under F.D.R. as a Director of

Negro Affairs? Which is the oldest college which had as its

original purpose higher education for Blacks? Who was the first great Black heavyweight

boxer in the 19th Century? Who was the Black biologist who received the first Spingarn Medal?

These are some of the questions answered in the revised edition of the Black Culture Quiz, prepared for the Sperry and Hutchinson Company (S & H) by Dr. Roscoe C. Brown, Jr., professor of Education at the New York University School of Education and Director of the school's Insti-tute of Afro-American Affairs and Carolyn A. Dorsey, an instructor at the School of Education.

The revised edition, now available, is the second issued by the company famous for S&H stamps. The first edition published in 1971. A forward states that "The authors and S&H dedicate this booklet to the goal that Black history and culture will soon be rightfully recognized for its role in enriching the lives of all Americans.'

The booklet is divided into sections: People and Their Work; Places and Events; Sports, Entertainment and the Arts, and Science and Economic Life.

The asnwers to the questions above are as follows: James Augustine Healy (1830-1900 became bishop of Portland, Maine, in 1875. He presided over the diocese of Maine and New Hampshire for 25 years.

Mary McLeod Bethune (1875-1955) was appointed to various posts by several presidents serving as director of Negro affairs in the National Youth Administration. She was a powerful figure in New Deal policies relating to Blacks and served F.D.R. as Director of Negro Affairs. Lincoln University of Pennsylvania is the

oldest college which had as its original purpose higher education for Blacks. It was founded as Ashmun Institute in 1854 by Presbyterians, near Oxford, Pennsylvania. In 1866, it was renamed Lincoln University.

Tom Molineaux fought all of the great heavyweights in his day in England and on the continent. The Spingharn Medal, established by Dr. Joel

E. Spingarn, a white who along with his brother, Arthur, gave many years of service to the NAACP, was first awarded to Professor Ernest E. Just of the Howard University Medical School for distinguished research in biology in 1915.

Tax Filing Period

CARSON CITY --- Motor vehicle owners in Nevada who are qualified to obtain a vehicle privilege tax exemption may now file at any time with the County Tax Assessor's Office before the privilege tax is due. In the past, the claim had to be filed before August 1 of the year in which it was due.

Registration Chief John H. Ciardella, Nevada Department of Motor Vehicles, states that as the result of a bill passed during the 1973 Legislature, the privilege tax exemptions dead-line of August 1st was eliminated. "Widows, orphans, blind persons and veterans who quali-fy, under the provisions of the Nevada Statutes, for an exemption from paying the vehicle privilege tax may file their claim during the year at any time on or before the date the tax is due."

Persons filing for a vehicle privilege tax exemption may do so at county assessor's offices throughout the state. Tax exemptions must be filed before a motorist may apply for a Nevada vehicle registration.
