LOCAL BLACK EDUCATORS TOUR US NAVAL ACADEMY

Levester Carter, Edna Perkins, Autumn Keyes and Mike Kinnaird returned Saturday, February 9 from a five-day tour led by Captain Zel Lowman, Las Vegas reserve officer and state legislator to the U.S. Naval Academy at Annapolis, Maryland.

The counselors, administrators and coaches were briefed by Naval officers, Midshipmen and civilian faculty members including VADM W. P. Mack, Superintendent; RADM Robert McNitt, Dean of Admissions; Dr. Gregory J. Mann, Chairman Behavorial Science Department and CAPT. Dempsey Butler, Director, Division of U. S. International Studies. Because of inclement weather they were unable to see the 4100-man Brigade of Midshipmen in dress parade or to take a Chesapeake Bay cruise on the yard patrol vessel at the Academy, but they did eat lunch in the Midshipmen's Mess Hall interspersed with the officer candidates to query them abouth their reactions to the program.
On Wednesday evening the educators visited

with Senators Alan Bible and Howard Cannon and Congressman David Towell in the Senate Office Building where the Nevada national legislators answered their questions on such major national issues as the energy crisis and Watergate deliberations. The Congressional delegates also spoke to the group on their activities in nominating young Nevadans for Naval and Air Force Academies and West Point.

Captain Lowman, who has led four such visits since 1956, said educators such as those attending this month have had much to do with the Navy's ability to maintain its present high admission standards.

Mrs. Florence Lloyd, a housewife was arrested and charged with manslaughter in connection with the shooting death of her sisters husband.

The homicide was alleged to have occured when Jerry Brown, sister of Mrs. Lloyd ca-ame to her place of business following a fight with her husband. According to reports Amos Brown, followed his wife to her sisters place of business and during an arguement he attacked his wife, but was restrained by a male employee of the business who managed to hold him on the ocustomers side of the counter. Where upon Mrs. Lloyd asked him to leave, Brown refused to leave when he made threating moves toward her she picked up her gun and shot him in the chest.

Ambulance attendants called to the scene, reported to police who arrived after them that Brown appeared to be dead.

Police were delayed in arriving due to their uncertainty as to whether the address

radioed to them was in North Las Vegas or in their territory.

At the time of the shooting there were several witness's in the store. Police took statements from the witness as well as the suspect.

None of the witness's seem to know just who brought Brown to the store.
