## **FISHING FACTS**

Creel census surveys of anglers by Department of Fish and Game personnel on South-ern Nevada waters indicate an improvement in bass fishing and trout angling success to be holding its own. Numbers of largemouth bass in the catch

at Lake Mead have increased recently, parti-cularly in the Overton Arm and Las Vegas Wash areas. Most of the bass taken recently have been small, with very few exceeding 15 inches in length. Nightcrawlers are rated best for bait when fished at depths of 25 to 40 feet. Waterdogs have been credited with some catches lately as well.

Angling for trout at Lake Mead equally good from both boat and shore. From a boat, trolling with flatfish and rapala type lures appear to be most effective in shallow gravelly shoreline areas, while from shore, the standard marshmallow, cheese and worm baits are scoring best. Overton Arm and Temple Bar areas rated best by National Park Service reports.

Crappies being reported in the catch from scattered locations, but as usual at this time of year, upper Overton Arm is providing the most action. Live minnows preferred but doll flies

and crappie jigs also effective. On Lake Mohave, bass fishing has been very good lately, particularly at Cottonwood Cove and vicinity. In this area, nightcrawlers fished like a plastic worm, have proven the best bait. Katherine Landing also receives a good rating

for largemouth bass. Good trout fishing has been restricted to the Willow Beach and Katherine areas with garlic flavored cheese and Floating cheese baits most effective. Largest trout creeled this past weekend tipped the scales at six and one-half pounds.

### LOST OR DESTROYED LICENSES

It can happen to anyone. A wallet goes through the washing machine, falls overboard, or works its way out of a hip pocket and is lost, leaving the fisherman or hunter without a license. If this should happen to you, Nevada Department of Fish and Game advises that state law requires you purchase a duplicate license before you attempt to hunt or fish again. Cost of a duplicate license, which must be of the same class as the original, is four dollars or a fee equal to the original license fee, whichever is less.

Duplicate licenses may be obtained from any license agency. Applicants must sign an affi-davit of lost or destroyed licenses which are also available from the license agents. Lost or destroyed deer tags, per

Lost or destroyed deer tags, permits or stamps such as the A5i

such as the Arizona fishing stamp must be replaced at the original cost if the fisherman intends to use them again. Issuance of a duplicate tag also requires signing of an affidavit.

Nevada Department of Fish and Game cautions fishermen and hunters that valid licenses and tags left at home or otherwise forgotten may not be replaced by a duplicate--no matter how far from home the person may be.

#### Marina and Boat Landing Reports

Lake Mead Marina - Bass running one and one-half to four pounds in size with waterdogs most effective bait. Most anglers fishing from boats with 25 to 40 feet listed as depth at which most fish are being taken.

Willow Beach Resort -- Trout have been running from 16 to 24 inches long with a 13pound, 34 inch rainbow taken two weeks ago restriction cable upstream. near the Recommended fishing locations include the twomile marker and Monkey Hole (15 mile). Zeke's garlic cheese rated good for bait with most angling recently from boat rather than shore.

Eldorado Canyonn Resort--Trout still hitting good in this area with a few up to four pounds. Bass fishing picking up with a rew up to rour pounders. pounders reported. Most spectacular recent catch was an eight pound four ounce largemouth. Waterdogs listed as most effective bait.

### VA FACTS

Veterans Administration identification cards showing eligibility for the agency's medical care program, CHAMPVA, are now being issued at VA hospitals and outpatient clinics, the agency

announced today. CHAMPVA is for widows and children of veterans who died of service connected disabilities. Care under the program is provided at VA expense at non VA hospitals.

VA reported that notices of eligibility or po-tential eligibility are being prepared for mailing by the end of March to beneficiaries identified from VA compensation rolls. Recipient

from VA compensation rolls. Recipients are advised to apply to VA hospitals and outpatient clinics for verification of eligibility and identification cards.

CHAMPVA - for Civilian Health and Medical Program - Veterans Administration - pays 75 per cent of the reasonable costs of hospital care. For outpatient care, CHAMPVA pays 75 per cent of the remaining costs in any calendar year after the patient has paid the first \$50. (For families, the deductible is limited to \$100 per year).

VA stressed that the new medical care program does not cover all wives, widows and children of veterans. The veteran must be totally and permanently disabled from a service connected cause or have died from a service connected cause after leaving service. Also excluded from coverage by CHAMPVA are those already eligible for the military program CHAMPUS, and most persons with entitlement for Medicare.

Patients who use non-participating medical care facilities must request reimbursement from a CHAMPUS claims office subject to deductible

and cost sharing requirements. Most medical facilities in the United States have received formes and instructions for making claims for reimbursement, and forms are available also from CHAMPUS fiscal agents throughout the country. Names of fiscal agents and full information on the CHAMPVA program are available through VA's 170 hospitals.
