MASS MEETING ON 235-1 HOUSES IN VEGAS HEIGHTS

A meeting of Vegas Heights residents will be held Tuesday evening, March 12, at 7:30 p.m. in Booker elementary school to deal with the condition of 235I housing and with the question of street improvements for the Vegas Heights and ask for their opinions and their advice on improvement of this area.

The meeting will be chaired by Assemblyman Cranford Crawford. Father Louis Vitale of the Franciscan Center will briefly present the history of the 235 I program in Vegas Heights and Noel McFarlane, a minority contractor will explain FHA's present plans for the areas as well as possible alternative plans that would involve community participation. Senator Joe Neal will explain Urban Homesteading, a program that has been effective in other areas of the country. Eleanor Walker of NAACP will outline the safeguards to the community that must be present in any program considered for the 235 I program. Louise Sanders of Poor People Pulling Together will explain the role for the Mayor's Task Force on 235 Housing. Street improvements will also be considered at this meeting.

The coalition sponsoring this community meeting includes Poor People Pulling Together, Clark County Welfare Rights Organization, NAACP, Franciscan Center, Consumers League and several church groups concerned about social justice.

HUDTESTING URBAN HOMESTEAD PLAN

The U.S. Department of Housing and Urban Development announced today that up to 4,000 single family houses will be sold to localities throughout the country for use by the communities for any legitimate purpose, including urban homesteading.

H. R. Crawford, Assistant Secretary for Housing Management who administers HUD's inventory of foreclosed properties, said the Department has a number of structurally sound houses across the country which it is willing to sell to communities for their unrepaired as—is value in an effort to conserve existing housing and regenerate interest in the urban core of these communities.

A number of communities located throughout the country, including many which are interested in starting urban homesteading programs, have expressed interest in having HUD convey such houses to them. These include: Compton and Los Angeles, Calif., Washington, D. C. Newark, N.J.; Detroit, Flint, and Pontiac, Michigan and Philadelphia, Pa.
