"In addition to our investigation of false data in computer files and dissemination of such data, we are looking into what appears to be a situation of international scope. This involves the relatively unknown presence of Interpol within law enforcement information channels," commented Wilber. "At first glance, Interpol seems to be a government agency; however we have found that it is, in fact, not a government agency but a private organization which has some 114 member countries who pay dues," he continued.

"Additionally, Interpol is under no govern-

ment control or scrutiny and apparently functions as a force without check. They know no national boundaries. Records of any U.S. citizen who has been arrested but not necessarily convicted are available to any Interpol member country."

"It is dismaying to conceive that there is an international private police agency with no official governmental control acting as a conveyor belt of data and reports between international police and law enforcement agencies," he concluded. According to Wilber, Interpol will be a separate study of the Commission.

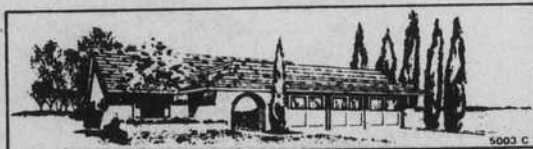

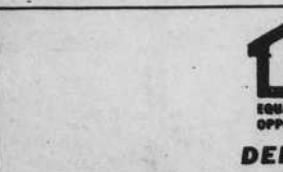
