# WARNING FIRE DANGER

Fire danger on the Toiyabe National Forest increases daily due to continued hot, dry weather. For this reason, in the interest of public safety and protection of natural resources, Regional Forester Vern Hamre has issued a fire restriction order for portions of the Toiyabe National Forest. The order is effective June 14.

The areas included in Mr. Hamre's order are: "All of the Toiyabe National Forest within Clark, Douglas, Lyon, Washoe Counties and Carson City, Nevada" and "that portion of the Toiyabe National Forest north of Bodie Creek in Mineral County, Nevada."

When a fire restriction order is in effect, visitors to the National Forest are required to obtain a valid fire permit if they plan to use fire outside improved campgrounds or picnic areas where facilities are provided for fire.

Smoking is allowed only at improved habitations, improved recreation sites, in an enclosed motor vehicle or at a point where at least an 18-inch diameter spot has been scraped to the bare soil for depositing ashes and extinguishing smoking materials and matches.

Permits for fire use in other than improved designated areas may be obtained from the Toiyabe National Forest Supervisor in Reno or District Ranger Offices.

These fire safeguards will be lifted when there is sufficient improvement in the fire situation.

Mr. Hamre is requesting the cooperation of all citizens in this important fire prevention effort.
