#### Will Blacks Ever Learn?

If you are about to read this article, it means one of two things: you are Black and have made the wisest choice available to you when you purchased this newspaper which is operated by Black folks for Black folks. On the other hand, you may be White and represent an interested small minority that prefers to remain abreast of the mainstream of Black thought. The informative news, the good news, the truth about our people is what our press strives

Black history is available in "hard to find" books: Black history-makers are found only in the Black press - newspapers and magazines. But we still face the same old problem: We read the wrong press. How many great functions have you attended which included the most moving speech you ever heard and then search the morning and evening news in vain for its re-

It's impossible to find any evidence of our continuing struggle, our modest gains or our grim determination to achieve in the White press. Stories about our front line soldiers just don't exist except on these pages. The Black press highlights cham-

pions like Jesse Jackson, Vernon Jordan, Leon Sullivan, Carlton Goodlett, Roy Wilkins, Dorothy Height, Katie Whickam, Fred Patterson. Ophelia Devore. Eddie Williams. Tony Brown, Frank Stanley, John Sengestacke, Maynard Jackson, Tom Bradley, Ed Brooke: Parren Mitchell, Lou Stokes. Charlie Diggs and the entire Black Caucus. and the list goes on, of people who are struggling to shape America.

But these people - all Black, are never going to be chronicled even for Herculean achievements in the racist press that still feels that news about Black people has but a limited audience in terms of community interest. But we must learn: Our entire quest for freedom will be postponed again if we allow the White press to dominate our lives by limiting our access to the truth.

Our hopes and dreams are tied to the future of a strong, economically viable Black press. The men and women who own it do not plead for their personal existence they plead for our collective future which requires all of our dedication to the principle that all men are created equal.

In a word, we had best get down to business and put our money where our best interests are served. It's the "American professionals work

### The Black Middle Class

The black middle class is the subject of a cover story in the current issue of Time Magazine.

"With little fanfare, without the rest of the society quite realizing it, more and more blacks are achieving the American dream of lifting themselves into the middle "They class," says Time. have become as well heeled, well housed, and well educated as their white counterparts. They have shown that reports of its demise to the contrary, upward mobility still operates in America.'

The Time story provides a detailed statistical analysis of black upward mobility. Between 1960 and 1971 the number of blacks professional and technical positions increased by 128 percent to 756,000, Time says. During the same period, the number of black managers.

The newsweekly notes that blacks have achieved the most widespread advancement through government employment and career service in the military. Blacks now comprise 12.6 percent of the U.S. armed services, and there are 12 black Army generals, three Air Force generals and one admiral. Some 60 percent of black for
