## THE PROSPECT **OF GERALD FORD** BY BAYARD RUSTIN

The resignation of President Nixon appears imminent as this is written. Even in the unlike-. ly event that the President does not voluntarily step aside, he faces almost certain removal from office by Congress within the next several months.

We are thus faced with the issue of how we respond to and what we can expect from the new president, Gerald R. Ford.

In terms of his relations with black people, Mr. Ford has constructed a congressional record that is at best mediocre. Although he supported most of the major civil rights bills adopted during the early part of the 1960's, he did so only after having led conservation efforts to weaken the legislation. More disturbing is the leadership Mr. Ford assumed in the struggle to limit busing as a desegregation tool. Mr. Ford has not only worked in the halls of Congress to curb busing, he has himself made busing a principal Republican issue during the current congressional campaign, falling easily into a patter established by George Wallace and later refined by Richard Nixon.



A more important consideration than his exploitation of the busing issue, however, will be Mr. Ford's response to the social and economic problems of poor and working people. Many experts believe that unemployment, already intolerably high, may exceed six per cent by the year's end. How will Mr. Ford respond to this crisis? And what of other essential social programs-national health insurance, educational programs, housing aid, and the like-under a Ford Administration?


Mr. Ford's previous congressional record is hardly encouraging in this area. He has opposed almost every important social innovation proposed during his congressional tenure, staking out a conservation, at times almost reactionary attitude towards domestic policy.

If what I have written thus far appears overly-gloomy, it is for a reason. And that is that I do believe that black people can expect anything of substance in terms of economic gains from po-licies laid down by Gerald Ford. There is nothing in his voting record, in his conduct as House Republican leader, or in his expressions of political philosophy that suggest anything except the imposition of orthodox conservative policies which have historically been disastrous for black people.

On the other hand, Mr. Ford has already voiced what appear to be sincere feelings that he should serve all the people. One does not know what Mr. Ford means when he promises to serve all the people--whether such a pledge will be translated into more humane policies, or whether it will re-result in merely symbolic gestures, such as meeting periodically with representatives of minority groups.

But even if the result is only symbolic, it will have been an improvement over the performan-Agnew both of Nixon a of their way to isolate themselves from all those who did not belong to their basic, conservative constituency.

There is also the possibility that Mr. Ford, like others before him, may move from his basic conservatism once he realizes the depths of the responsibilities of the office. One does not anticipate his being transformed overnight. But one should also not rule out the possibility that, at least in one or two areas, Mr. Ford will break from his conservative past to attempt some initiatives for social change.
