E.O.B. SACK LUNCH PROGRAM SUCCESS

The Economic Opportunity Board has completed another successful year of its Sack Lunch Program, which provided 75,000 Class lunches to low-income youngsters in the Clark County area. J. David Hoggard, Executive Director of the EOB, said that the program was meant as a summer supplement to the regular hot lunch program run by the school district during the school year. "It often provides the only nutritious meal a child receives all day," he stated.

The program was in operation from June 10, 1974, through August 16,1974, and served lunches at 19 recreational sites to approximately 1,500 youngsters a day. According to the Department of Agriculture, which funds the program, the lunches supplied 1/3 of the minimum daily requirements of the basic four food groups of meat or alternate, vegetables and fruit, grains

and cereals, and fats.

Sites for distrubution were the Operation Life Center, the Boys Club on East Carey, Doolittle Center, the Franciscan Center, James Anderson Park, Herbert Gerson Boys Club, Addeliar Guy Boys Club, Henderson Boys Club, the Head Start center at 909 Morgan, and the New Jerusalem Baptist Church. Additional sites were the following schools: Lois Craig, Jim Bridger, Rancho High, Jo Mackey, Tom Williams, Lincoln, Kermit Booker, Madison, and Kit Carson.


