Both young men were booked on the charges of robbery and attempted murder.



Multi Million in World Wide Law Suits Filed Against Police

The Church of Scientology's Commission on Law Enforcement and Social Justice has released the first results of an international investigation into illegal use of Police forces, by what they term "vestal interest groups, using and circulating false police records and dossiers on groups and individuals." The investigation has led to the Church of Scientology initiating 18 law suits against police agencies for circulating what they term "completely falsified and inaccurate police reports on our very own church.

Rev. Vaughn Young National Director of the Commission for the U.S. stated, "we have initiated suit against, the German Federal Police Interpol (The International Criminal Police Organization), the head of Scotland Y ard, the German Better Business Bureau, and various individuals and agencies connected to the circulation and distribution of a false report on the Church. These agencies are being sued by various Churches around the world, in L.A., Washington, D. C., New York, Toronto, England, Denmark and Germany. Our own personal experience with this only indicated that the practice of false police records must be widespread. We have now taken the issue to the public. Local commissions are forming throughout the United States collecting information from citizens who have been victimized by false police records. We want the people to know that they no longer have to feel afraid or apathetic about trying to correct a false police record.'

The National Commission on Law Enforcement and Social Justice, has been running ads nationwide, requesting information from citizens who have been victimized by false police records, or been the effect of vested interest pervision of its accuracy. International crime, groups using police records to discredit them.

According to Young, "testimonies are coming in daily across the country from citizens who have not been able to correct their police records. We are now in the process of verifying each case, and soon will be releasing the data. This practice is more widespread than we had imagined.'

Young explained the background of the Churches law suits, "The Church in demanding reform of current inhuman psychiatric abuses, launched an attack on the Max Planck Institute (the former Kaiser Whilhelm Institute of the Nazi's), through our news Journal Freedom. During this attack the police at the request of the Max Planck Institution, asked for confidential information on the Church from Scotland Yardby way of INTERPOL. False information was fed back through INTERPOL to the psychiatric institute and others. We first became a-ware of the report when a reporter in Munich showed it to a Church official there. T correct the information the church sent packs of documentation, and a request to correct the report. When the police ignored these requests we filed



"The tactics of using 'official police reports'

"The tactics of using opponents is not new," he added. "It was brought to perfection by Heinrich Himmler former head of the German police. (Himmler took control of Interpol in 1938 and moved it to Berlin).

"We recently have formed an entire section of the Commission to investigate Interpol. Interpol is under no Soverign power and has complete freedom to circulate reports internationally on citizens and groups with no external su-
