**BLACKS SEEKING  
WORLD FOOTBALL  
LEAGUE FRANCHISE**

WASHINGTON - (NBNS) -- A black group of businessmen have \$4 million pledged to buy majority control of the Florida Blazers (originally the Washington Ambassadors) if they can get a commitment from the city to lease RFK Stadium to them.

That elusive commitment is now being sought by a Washington restaurateur and hotelman, Ed Murphy, who says he has associates in the nation's capital as well as Texas pledged and committed to up the money for the majority interest.

The man who is still the owner of record of the World Football League team says he has offered the Washington Redskins of the National Football League a \$50,000 compensation for the last half of the WFL's 20-game schedule.

He is also trying to persuade the D. C. Armory Board to share half of its income from parking and concessions with the Redskins, who receive none now.

Both efforts are aimed at getting "temporary relief" from the Redskins' exclusive lease on the stadium. He is proposing a five-year contract with the Redskins.

Murphy is ready to make a deal with the Redskins for use of the stadium, but has received no response to letters to the club president or the mayor of the city.

"Now is Edward Bennett Williams (president of the Redskins) willing to tell members of the black community that they cannot go into business with a WFL team and play in a public facility here, RFK Stadium?" asked E. Joseph Wheeler, the present owner of the WFL squad. "Isn't it a shame when a group can raise \$4 million and can't get to use the stadium," declared Murphy. "People can't get tickets to Redskin games, but I am sure the mayor has tickets. We have a tax problem in this city and a stadium

that is not being used except on Sundays, and the mayor and Williams do not answer me."

"I think it is beautiful," said Wheeler, "that blacks are coming forward in Washington to arrange majority ownership. "I have met some of Murphy's associates and they have proper financial backing for a professional football team, The team has a good record, 6-2, and is leading the East Division of the WFL."

"With all the interest in the black community there would be a waiting list of 18,000 for tickets," Wheeler continued. "If Williams turns down Murphy's people, then it's not the money. It's something else."
