Ruby Says

The money will be used for the EOB's outreach and counseling program which serves 500 alcoholics and their families in North and West Las Vegas.

The State Division of Rehabilitation's Bureau of Alcoholism and Drug Abuse has granted the Economic Opportunity Board's Alcoholism Program \$16,726 for continued operation during 1975, according to J. David Hoggard, Executive Director of the EOB. The local program provides outreach and counseling to 500 alcoholics and their families, in addition to disseminating information on alcohol abuse to other agencies and to the general public.

The Agency had expressed concern that with the Federal grant for CARSON, a residential rehabilitation house for alcoholics, interest in and support for the community outreach program might vanish. "However," stated Hoggard, "seeing the need for continuation of the successes of the program, the State has extended these monies to the EOB in order that it can maintain its operations through June of this year."

Hoggard indicated that he had "high hopes" that the State will refund the program in its next fiscal year.

"This, said Hoggard, "is an outstanding example of State responsibility as designed under the federal guidelines for use of Revenue Sharing monies under what has been called the New Federalism."

He explained that recently Federal dollars have been returned to the States and local governments for them to use, along with State funds, to meet local needs and that the State's Bureau of Alcoholism and Drug Abuse was showing "true leadership in best utilizing revenues to end human misery."

BLACKS OFFER ALTERNATE PLAN FOR PUBLIC BUS ROUTE

The Las Vegas Transit Authority will go before the Public Service Commission on Tuesday, January 28, 1975 at 10:00 am. The purpose of the hearing will be to request permission to return to the routes and schedules used on the Westside of town prior to September 29, 1974.

The present routes and schedules have been under constant fire from the NAACP and residents of the Black Community.

Eleanor Walker, president of the NAACP said, "The NAACP represented by attorney Charles Kellar, received absolutely no consideration in a court appearance in December."
