

SCIENTOLOGY MINISTERS PETITION WHITE HOUSE N.C.C.

Representatives of the National Council of Scientology Ministers, a national group composed of ministers of the religion of Scientology, met Friday, at the White House with President Ford's personal Liaison Officer of the National Council of Churches, Dr. Ted Marrs.

The Council delivered a petition to President Ford calling upon the Chief Executive to "Direct the federal agencies under your control to make available to any religion or church, upon their request, any records or information collected on that religion and its activities and to expunge from those files and records of federal agencies any false, malicious or defamatory information that can be proven to exist."

Rev. Arthur J. Maren, spokesman for the Council, said that the effort was inspired by the inclusion, of eleven religious groups on the Internal

Revenue Service "Enemies List," disclosures of FBI actions taken against religious bodies, and intelligence agency surveillance of churches in America: "We have studied this situation and have traced much of the difficulty certain religious organizations are experiencing to the prevalence of false information on them and their activities in the files of various federal agencies" Maren said. "Although the Freedom of Information Act should assist churches in uncovering and correcting this inaccurate data, our experience shows that government agencies have not been in compliance with the spirit of the law."

"It is not uncommon to suffer inordinate delays and evasions of the Freedom of Information Act by government agencies. The Council also made a submission on these violations which Dr. Marrs indicated would be forwarded to the Justice Department for their review."

The Council reported that it was "Pleased to have the opportunity to inform the President of this situation; and, according to Rev. Maren, "We are optimistic that the President will act positively to help preserve the guarantees of Freedom of religion in the United States."

HELP NEEDED

Retired and nonworking people who enjoy worthwhile volunteer work, are needed to assist blind and handicapped trainees at Opportunity Village Association for Retarded Citizens (OVARC).

The plea for help was issued by Miriam Speck, Activities Center director at OVARC. She explained that while Opportunity Village has a highly skilled staff of programmers, counselors and teachers for trainees in the sheltered workshop, certain blind and multiply handicapped individuals require constant guidance.

"Unless you've wor-

ked with less fortunate people," Miss Speck stated, "it's easy to take for granted the things we are able to do for ourselves each day. In working with our trainees at Opportunity Village, volunteers gain an added appreciation of the blessings we have."

Miss Speck said that anyone volunteering should be able to work three to five days a week for several weeks, at least and be able to donate three to five hours time on each of those days.
