

They will be considered the residents of the City and they will be governed by this commission, but they will not have any voice in the function of this commission. They will have to vote for a county commissioner.


Some are calling this discrimination against these residents. Whether it is or not will ultimately have to be determined in a court.

It does not, however. Lawerence Albert has been a leasee in this motel for the past 15 years. This landlord, now wants to evict his best tenant. Personnal grudges should not play any part in a business venture. But apparently, the Leroi Corp. has a personal gripe with Albert because he is black, or for some other invalid reason. Albert rents the Hide-A-Way Bar from this

corporation, he rents the space for the VOICE hewspaper, and he just opened the A&J Market, another lease from this corporation.

Albert plays a bigger part than renter from this organization. He operates the only bathroom for this entire complex, not only that he pays for the upkeep of this community restroom. And yet, this firm wants to evict him. This is the very height of bad business. If it were not for Albert's bar, everyone who works in this complex would have to run home, or the nearest service station, to use the bathroom. If anyone should be evicted, it should be this corporation so that someone could take over this motel and give its tenants the services they deseparately need.

Albert is not, however, the only mistreated

teneant; he just the biggest. The people who rent homes here, and pay the same prices as they would in the Dunes or MGM hotels, get despicable service. They do not have television sets. They find half the time they do not have towels in their rooms and the linen service is just as bad.

Its pool has also been condemned. What is wrong with this coroporation? Will it let its prejudices destroy it?

If it had an unlimited clientele, then its actions could be understood. But its very life depends on Blacks using its facilities. It turns right around and treat them like dogs. They will not tolerate this much longer.

## NNPA EDITORIAL-America's **Double Standard**

Within the past few weeks, it has come to light that our Department of Defense is cutting back on black recruits, implying agreed upon racial quotas set behind closed doors.

Now we are not opposed to racial quotas. In fact, we favor them. We would be satisfied with a 10 percent across-the-board quota allocation. A 10 percent limitation in volunteer military recruitments is all right, if we can have 10 per-cent of all government and private jobs at every

level, and our fair share of contracts. One reason for the large number of Blacks volunteering for the military is the lack of equivalent civilian positions for them. While blacks make up approximately 15 percent of the government employees, and somewhat larger percent of the private work force, the level of their employment is concentrated in the lower grades.

For example, blacks compose 20 to 70 percent of the bottom grade government employees, but hold an average of less than three percent of the high level positions. The same trend prevails in industry, only worse.

But every time the Equal Employment Opportunity Commission or the affirmative action people raise the question of quotas, government and industry and most of our liberal friends throw up their hands, insisting that quotas are undemocratic. Instead, meaningless goals are offered as a substitute.

Yet when it comes to the military, and blacks begin to join up in percentages larger than their representation in the population, h a n d s go up again. Now the government wants quotas.

And to prove it, within a year, it has cut back on black Army recruits from 30 to 17 percent, the Navy, form 14 to 6 percent, and the Air Force, from 22 to 12 percent.

A fight againist military quotas for blaks is be-ing conducted by the Naional Newspaper Publishers Association, the Urban League, the Joint Center for Political Studies, and members of the Congressional Black Caucus, especially Rep. Ronald Dellums, a member of the House Armed Services Committee. But the chance of victory is not good without larger support from blacks. The voice of protest must be heard. America cannot have a double standard on quotas.
