

People also used as a reason to fire Henry, the fact that he had been dismissed from his previous job up north before he took over his present post.




Williams rightly said he could not let this have any bearing on his decision. He said his only concern was how well Henry community should join forces and push for more protection had performed in his present position.

Black Newspapers, Sororities Join Hands For Communities

(NNPA)-The black newspapers of America and the leading fraternities and sororities joined hands here recently in a unified commitment for the uplift and advancement of the black community, Said Dr. Carlton B. Goodlett this week.

Dr. Goodlett, president of the National Newspaper Publishers Association and editor-publisher of the San Francisco Sun-Reporter/Metro-Reporter, stated that this relationship between his organization and the Greek letter groups was developed through discussion and consulation at the recent NNPA convention here.

Those who participated in the discussion with the black publishers are: Dr. Elbert E. Allen, grand polemarch, Kappa Alpha Psi; Ms. Lillian P. Benbow, national president, Delta Sigma Theta; Judge Marion W. Garnett, grand basileus, Omega Psi Phi; Dr. Annie Lawerence, grand basileus, Sigma Gamma Rho.

Mel Patrick of Phi Beta Sigma; Mrs. Barbara K. Phillips, president-elect, Alpha Kappa Alpha; Mrs. Marian Shannon, national publicity director, Zeta Phi Beta; Dr. Walter Washington, general president, Alpha Phi Alpha and president of Alcorn State University; and Charles Wright, vice president, Panhellenic Council. Dr. Eugene Mitchell, publisher of the St. Louis Argus and medical director of Homer G. Phillips hospital in St. Louis, presided over the discussion.

Among other things, the discussion focused on the many projects being conducted by the 500,000 members of fraternities and sororities to help improve the quality of life for blacks and on the need for publication of news stories about these services by the Black Press so that mote of the people will share in them.

For example, the Omegas offer scholarships each year to high school graduates, the Zetas have a national "Stork's Nest" project through which they give assistance to needy expectant mothers.

The Alphas are pushing career development and the Deltas conduct job fairs and other vital programs. The Kappas promote leadership training for teenagers, and the Sigmas have their SADD program -- "Sigmas" Attack on Drugs and Defects which it conducts in cooperation with the National Foundation for the March of Dimes.

This place charges the same prices for rooms as the real hotels downtown and on the Strip, with one fourth the services. It has no maid services, no towels in the rooms, and half the time its air conditioning does not work.

This hotel treats its largest tenant like he had just moved in. It persecutes him, seemingly just to try to find out how much he will take.

Let's clean-up this community, starting with this half-way hotel.
