FTC unearths funeral home rip-off's

WASHINGTON-The Federal Trade Commission proposed keeping with his love and respect for the deceased." rules recently to prohibit the \$2 billion funeral home industry from taking advantages of customers' grief and vulnerability to sell them unwanted services at undisclosed prices.

Violators could be subject to fines of \$10,000 for each offense.

After a two-year study, the commission said some of the country's 22,000 undertakers engage in the unscrupulous practices such as misrepresenting the need to embalm a body that is to be cremated, disparaging a customer's concern for price or "uglification"-the practice of showing customers unattractive caskets in ugly colors after they've asked to see something less expensive.

which advertised, "Undertaking \$149-Complete." When a funeral homes on the basis of price. customer asked about the \$149 funeral, the FTC said, "the consumer that what he really needs is a funeral more in \$100,000 to customers who paid for cremations.

The FTC said nearly two million people die each year in the United States and the average funeral, service and burial costs over \$3,100, but "even when the consumer goes to the funeral home to discuss arrangement it is difficult for him to obtain information or prices."

Under the rules, undertakers would be required to give prices over the telephone.

An industry fight against the rules proposed by the FTC tember 28. staff-the first broad federal attempt to regulate the industry-was indicated.
