The matter of funding the Pre-trial Release Program for another year was before the Board of County Commissioners on June 1, 1976.

There was considerable deliberation both for and against the program. I am told that in support of the program and represented at the meeting was an entourage of Poor People Pulling Together (PPPT).

It appears when a person accepts poverty as a way of life, we might expect them to fight for a pre-trial release. What the heck, it's the tax payers money anyway and for the most part they are only working people whose voices are seldom heard.

The funding for the program was defeated by a vote of five to two. I think it is commendable on the part of those Commissioners who voted against the funding of the program and I am quite certain that the three judges who sit in Justice Court will continue to release indigent people from jail who are established in the community and meet the criteria of the court.
