## Food Stamps And You

WASHINGTON --- The food stamp maximum income eligibility standards were recently increased for 1-and 2-person households July 1, the U.S. Department of Agriculture (USDA) announced recently. The maximum allowable income standard for a 1-person household in the 48 states and the District of Columbia will

increase from \$215 to \$245 per month, and from \$307 to \$322 for 2-person households.

Because the USDA proverty guidelines increased for 1-and 2-person households, eligibility levels for these households also increased.

Food stamp regulations require the income eligibility level be set at the higher of either (a) the Secretary's income proverty guidelines, or (b) the level at which the total coupon allotment equals 30 percent of income. In the case of 1-and 2-person households, the Secretary's poverty guidelines are the higher figures. The income eligibility levels for all other households reflect the higher allotmentbased calculations, and remain the same.

Coupon allotments for all household sizes remain the same, reflecting the cost of the thrifty food plan in Febuary 1976, which was unchanged from August 1975. The Food Stamp Act directs that coupon allotments be adjusted twice a year to reflect changes in food prices as published by the Bureau of Labor Statistics. Maximum income eligibility standards are based on allotments and are therefore adjusted at the same time.

In keeping with the June 18, 1976, U.S. District Court decision for a preliminary injunction in the case "Trump et al v. Butz e6 al," all other provisions of the Food Stamp Act, as amended, remain in effect until further court action, or Congressional action, is decided upon.

Maximum monthly income eligibility standards, effective July 1, for the 48 states and District of Columbia are:

One-person household . . . . . . . . . . . . . . \$245 Two-person households..... Four-person households . . . . Five-person households . . . . . . . . . . . Six-person households . . . .\$873 For each additional household member over eight, add . . . . . . .

## Jimmy Carter and Blacks

Jimmy W h o ? was the question asked by Atlanta's largest daily paper. Millions have asked the same question since Carter started running in the primary. Blacks have a great stake in the presidency and responsible Blacks now know the necessity to get rid of Ford-Nixon attitudes about Blacks in education, employment, inflation, etc.

How about Carter on education? In Plains, Ga., whites support private academies. Carter denounced this and sends his daughter, Amy, to the neglected school, predominantly Black.
How about Carter on employment? Leonard

How about Carter on employment? Leonard Wright farms 200 acres of the Carter farm on a 50/50 basis. Last year he made \$15,000— (did you?). Carter feels that high employment will make payrolls and supply taxes that will overcome the inflation problem. Carter has endorsed in principal the Hawkins-Humphrey bill which provides a government public works job if no public jobs are available. public works job if no public jobs are available and then seek a private enterprise job for you. He says millions of jobs are possible by repairing railroads and transit systems, better housing, health care, retarded children, alcohol and drug addiction, preventive health care, remedial school instruction, road repark rehabilitation, pollution control, job training, etc. Cost estimates already made indicate the cost of providing jobs would be little more than welfare and would give dignity to Blacks and others on help programs. Carter has expressed deep concern over the 40 percent unemployment of Black youth and wants to put them to work at minimum adult pay and would put them on federally created jobs something like the Civilian Conservation Corps (CCC) and Works Progress Administration (WPA) projects. These were created by President F.D. Roosevelt and got this country started back to economic stability after the Great Depression had created 30 percent unemployment.

How about Carter on economics? Carter is one of the new waves seeping into the American economy. He will not likely cancel any provery programs, but you must expect he will call for evaluation and justification of each program. Results — not rhetoric — will program. determine whether they stay or go. Pork barrel programs that provide personal gains and provides huge executive salaries will be doomed. Conservative is not a good word for Carter's description, because we now associate it with anti-black, anti-poor, and false law and order vocal garbage. Prudent is better.

How about Carter on religion? Carter is a Southern Baptist. They are the only Baptists I have heard of who will sponsor and support black churches. Black Baptist churches usually receive no help as do Methodists, Presbyterian, etc., whose mother churches or organizations finance them.

How about Carter on presidential qualities? Carter was governor of Georgia and based on reports of Georgia Representative Andrew Young and Martin Luther King, Sr., he cared, worked for and supported black improvement, both cosmetic and economically. Of great importance is the fact that the United Press, Associated Press, etc., have sent out investigators to find any possible faults or deficencies in Carter. Little or none have been found. Such a record in a politician is difficult to find these days. Blacks seem to have a real live one coming.
