## Church Files Lawsuit Against

#### North Las Vegas Police Department

A suit has been filed against the North Las Vegas Police Department (NLVPD) by the Church of Scientology, calling for the release of all files being maintained by the police department on the religious organization.

The suit, filed in District Court for Nevada, was necessary, according to church spokesman, "Because all other administrative remedies have failed to secure the release of all infor-mation being maintained on us."

The suit further states that "The false and

misleading information contained in the investigative reports has been selectively leaked and disclosed to the media and other persons in violation of the Petitioner's right under the Fourth Amendment to the United States Constitution to enjoy privacy in pursuance of its religious func-

tion and activities."

"Our church has been harassed for over 25
years by false information maintained in government files. It is the practice of these agencies to distribute to many other agencies copies of their material, with the result that in short order every major agency in the country has the same material. The job of cleaning up these false-hoods is long and arduous, and is only compli-cated by the unwillingness of agencies such as the NLVPD who refuse to help us see that all information is correct, and require us to resort to litigation," O'Brien continued.

The Church of Scientology has filed over 2,000 Freedom of Information (FOI) requests to numerous government agencies in order to combat the wide dissemination of misinformation to these other agencies, and has been offering their assistance and experience to other churches, who may have the same problem, in using the

FOI to see their files.

Any organization could be victim to false information, particularly socially reform minded churches. Our assistance to them will make them more able to continue to pursue their social actions unimpeded by a misled government agency. Then we will be able to see a reduction of crime and drug abuse, and the beginnings of real trust for self and others in the community," O'Brien concluded.
