# DUNN IN JAIL

Rev. Albert Dunn is in jail again. He was sentenced to 60 days in the county jail by Judge Robert Mullen. This is the second time Dunn has been sentenced to a jail term - each time by the same judge.

It is ironic that Mullen has imposed sentence on Dunn. The earlier verdicts, all handed down by Mullen, were appealed to the Eighth Judicial Circuit Court. For reasons still not clear, the case found its way back to Mullen's court.

REV. ALBERT DUNN

On June 4, 1971 a Consent Décreé was entered in the case of United States of America vs. Nevada Resort Hotel Association, et al. This race discrimination suit required, among other things, that most Strip hotels not discriminate in employment and that they take aggressive action to provide job opportunities for Blacks in the category of "Officials and Managers." These positions pay from \$15,000 to \$100,000/plus a year.

The "agressive" affirmative action of the Hilton Hotel could not be worse if it were headed by Sheriff Bull Connor of Alabama. Their record looks like this:

#### OFFICIALS & MANAGERS

March 31, 1972 - Total Males, 243; Black Males, 9 - Percent Black Males 3.70%.

June 30, 1976 - Total Males, 298; Black Males, 9 - Percent Black Males 3.02%.

In five years they expanded this category by 55 people - ALL WHITE!! Similarly, in the category of "Technicians" the Hilton has made progress toward apartheid. The picture for technicians at our own little South Africa would make Ian Smith proud:

#### TECHNICIANS

March 31, 1972 - Total Males, 14; Black Males, 0 - Percent Black Males 0%.

June 30, 1976 - Total Males, 39; Black Males, 0 - Percent Black Males 0%.

The Hilton, through their aggressive recruitment and mandatory training has not been able to develop any "qualified Negroes" for officials, managers or technicians. However, don't let the above figures fool you. Blacks are employed at the Hilton, and our numbers are increasing:

March 31, 1972 - Total Work Force, 2203; Black Work Force, 344 - Percent Black 15.6%.
